

Examination and other Fees per annum per student	: \$500



**Sharing of expenses between MOST and GIET:**

- > 25% of students will fully pay the Tuition Fee=\$1200 and Exam. & other Fees = \$500
- > 50% of students will pay the Tuition Fee =\$600 and Exam.& other Fees = \$500
- > 25% of students will be given full waiver of Tuition, exam & other Fees and living expenses will be covered by MoST.

**Payment Mode:**

For 4 years UG Courses and For 2 years PG Courses – Once in every year (at the beginning of the academic year.

The MoA shall be valid, initially for a period of four (4) years from the date of Agreement, extendable by mutual consent.






