- ◆ Will admit the eligible students as per Tamil Nadu / A.U norms sponsored by "MOST" in the following courses, departments.

  - ▶ Electrical and Electronics Engineering
  - ▶ Computer Science & Engineering
  - ▶ Biomedical Engineering
  - ▶ B.Tech. Information Technology
  - ▶ MBA
- Will impart education and training in the chosen course of study for the prescribed duration of 4 years in B.E./B.Tech., M.E./M.Tech. of 2 years and MBA of 2 years.
- Will offer employable training and provide facilities for extra-curricular activities
- Will provide Hostel facilities to all students sponsored by "MOST" at their international students Hostel and provide adequate security arrangements.
- Living expenses will be borne by "MOST" for all the students irrespective of fee waivers.

**Fees in USD payable to PSNACET by a student admitted in the academic year 2017-2018:**

Tuition Fee per annum per student	: \$1200
Living expenses per month per student	: \$300
Examination and other Fees per annum per student	: \$500

**Sharing of expenses between MOST and PSNACET:**

- 25% of students will fully pay the Tuition Fee=\$1200 and Exam. & other Fees = \$500
- 50% of students will pay the Tuition Fee =\$600 and Exam.& other Fees = \$500
- 25% of students will be given full waiver of Tuition fees. They will pay only Exam & other Fees and living expenses.
- Living expenses per month per student \$ 300 is common to all the above category of students.

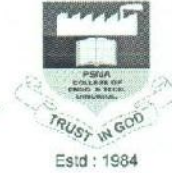
